- Agenda Item 6: Tim & Janet Anthon-Pleasant View Park Rd Variance The Anthon's presented their proposal. They would like to put a second story on the home in order to add another bedroom. They are also looking at adding on to the garage. Because the home is too close to the road a variance is needed for the request. A public hearing is scheduled for June 6, 2002.
- Agenda Item 7: Smart Growth Attorney Clark indicated that there is some new information on variances and how the Supreme Court views these requests. He will be sending the Commission information when he receives it. Doug Richmond also indicated that the County has sent out maps that they want color coded as to zoning.
