

MINUTES FROM NOVEMBER MEETING  
TOWN OF WEST POINT

The town board of West Point met at the town hall on November 1, 1983 at 8:20 p.m. The members present were: Robert Lichte-Chairman, Alex Lochner-1st Supervisor, Earl Lanzendorf-2nd Supervisor, Edith Eberle-Clerk, Margaret Hanson-Treasurer and Harry Sawyer-Assessor.
