The Treasurers Report was General-\$62,784.12; Holding Tank-\$251.36; Tax Account-\$1,156.04. A motion was made by Alex Lochner, 2nd by John Benish to accept the Treasurers report - motion carried.

A invitation was read to a open house at the new Sauk Prairie Ambulance building on November 10, 1985 from 1:00 p.m. to 4:00 p.m.

A Ordinance for selling of Intoxicating Liquor in the orgininal package or container in multiples not to exceed 4 liters at any one time to be consumed off the premises. A motion was made by Alex Lochner to adopt the Selling of Intoxicating Liquor Ordinance, 2nd by John Benish - motion carried.

A letter was read from Columbia County for stray dog resolution - Chairman John Benish will go to Columbia County meeting and voice the boards opinion against the Dog Resolution.

A Resolution was presented to pay the first half of Real Estate Taxes on the 17th of February, 1986. A motion was made by Alex Lochner to adopt the resolution, 2nd by John Benish - motion carried.

Amendment to Resolution 2-1985 was presented that the Town of West Point will absorb the fee set for fire calls and fire rescue runs in its tax collections for all voting and tax paying residents (non tax paying residents will be billed for the fee set by the local fire department). A motion was made by Earl Lanzendorf to adopt the amendment to Resolution 2-1985, 2nd by Alex Lochner - motion carried

A motion was made by Alex Lochner to accept the 1986 Budget as presented \$35,200.88 (detailed copy attached), 2nd by Earl Lanzendorf - motion carried.

A motion was made by Earl Lanzendorf to grade Rausch Road, 2nd by Alex Lochner - motion carried.

A motion was made to adjourn the meeting by Earl Lanzendorf, 2nd by Alex Lochner - motion carried.
