The Town Board of the Town of West Point held the regular monthly meeting on Thursday, June 5, 1986 at 8:30 p.m. The members present were: John Benish-Chairman, Alex Lochner-1st Supervisor, Earl Lanzendorf-2nd Supervisor, Edith Eberle-Clerk, Harry Sawyer-Assessor and Margaret Hanson-Treasurer was absent.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in four places.

The minutes from the May meeting were read and a motion was made by Alex Lochner to approve the minutes, 2nd by John Benish - motion carried.

The Treasurers report was as follows: General-\$37,077.43; Holding Tank-\$265.78; and Tax Account-\$1,354.61. A motion was made by Earl Lanzendorf to approve the Treasurers report 2nd by Alex Lochner - motion carried.

A motion was made by Earl Lanzendorf to change Resolution 3/86 to read as follows - town board to borrow the amount of \$25,000.00 as a long term note (not short term), 2nd by Alex Lochner - motion carried.
