

MINUTES FROM THE SEPTEMBER MEETING

The Town Board of the Town of West Point held its regular monthly meeting on Thursday, September 4, 1986 at 8:30 p.m. The members present were: John Benish-Chairman, Alex Lochner-1st Supervisor, Earl Lanzendorf-2nd Supervisor, Edith Eberle-Clerk, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

A motion was made to approve the minutes as were sent out to the Chairman and Supervisors by Alex Lochner, 2nd by John Benish - motion carried.

A operator license for Patty Schoepp from Schoepp's Cottonwood Resort was presented. A motion was made by Alex Lochner to grant the license, 2nd by John Benish - motion carried.

Ken Foss from the Ambulance Committee gave a report from the Ambulance Board.

Bob Buchanan would like a special meeting to look at the improvements of his land (air strip). The town board decided to meet on Monday, September 22, 1986 at 1:00 p.m. to look at his improvements, at the air strip.

Chairman John Benish <sup>+ Supervisors</sup> would like a copy of the town property (as public assess).

The town board talked about the Robert Jonas property. Mr. Jonas as not contacted Chairman John Benish or started to clean up the property, Mr. Jonas has one more month to contact Chairman John Benish - it will be brought up at the next meeting.
