The Town Board of the Town of West Point held its regular monthly meeting on Thursday, October 9, 1986 at 8:30 p.m. at town hall. The minutes from the September 22, 1986 meeting were read. A motion was made by Alex Lochner to approve the minutes, 2nd by Earl Lanzendorf - motion carried.

The Treasurers report was as follows: General-\$48,893.48; Holding Tank - \$265.78. A motion was made by Alex Lochner to accept the treasurers report, 2nd by Earl Lanzendorf - motion carried.

A letter was read from the residents on Pulvermacher Road (Leonard & Betty Thomas, Gary & Marie Breunig, Dick & Ginny Diehl) asking the town board to change the name of the road to West Point Road. After discussion, a motion was made to leave the road named as is because West Point Road would be confusing by Alex Lochner, 2nd by Earl Lanzendorf - motion carried.

A letter was read from Harvey (Budd) Rasmussen asking the town board to rezone 2.5 acres of land to Industrial - the zoning hearing at Columbia County will be on Nov. 3, 1986. After discussion - a motion was made to grant 2.5 acres for his building site to Industrial by Alex Lochner - 2nd by Earl Lanzendorf - motion was carried with one vote no.
