The town board of the Town of West Point held there regular monthly meeting on Thursday, November 12, 1987 at 8:00 p.m. at the town hall. The members present were: John Benish-Chairman, Fred Thistle-1st Supervisor, Earl Lanzendorf-2nd Supervisor, Edith Eberle-Clerk, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in four places.

The minutes from the October 8, 1987 meeting were read. A motion was made by Earl Lanzendorf to approve the minutes as read, 2nd by Fred Thistle, motion carried.

The treasurer's report was as follows: General-\$12,985.41; Holding Tank- \$479.72; a motion was made by Earl Lanzendorf to accept the treasurer's report, 2nd by Fred Thistle - motion carried.

A letter from Columbia County stating the Slack's Inc. zoning from Agricultural to Commercial was passed.

A motion was made by Earl Lanzendorf to have the roadside brushing done on a job basis with the following specifications: brush to be cut to ground level, stumps painted each day, proof of insurance, and brush disposed of on the job site, 2nd by Fred Thistle - motion carried. The following roads were suggested to be done - Slack Road, Reynolds Road and Lovernig Road.

A motion was made by Earl Lanzendorf to pay the following amounts for work done at the Sanitary Landfill - \$5.50 per hour per man and \$25.00 for man, tractor and equipment; 2nd by Fred Thistle - motion carried.

The following Operator Licenses were presented - Thomas Ballweg, Robert Pings and Linda Clemens for Lake Wisconsin County Club. A motion was made by Earl Lanzendorf to grant the licenses, 2nd by Fred Thistle - motion carried.

A revised copy of the public nuisance ordinance was read. A motion was made by John Benish to adopt the Public Nuisance Ordinance as read, 2nd by Fred Thistle - motion carried.

A motion was made by Earl Lanzendorf to table the Mobile Home Park Ordinance for one year, 2nd by John Benish - motion carried.

A motion was made by John Benish to adjourn the meeting, 2nd by Fred Thistle - motion carried.
