The town board of the Town of West Point held the regular monthly meeting on Thursday, August 3, 1989 at 8:00 p.m. at the town hall. The members present were: John Benish-Chairman, Fred Thistle-1st Supervisor, Dave Cole-2nd Supervisor, Edith Eberle-Clerk, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in four places.

The minutes from the July 6th meeting were read - a motion was made by Fred Thistle to approve the minutes as read, 2nd by Dave Cole - motion carried.

The Treasurer's Report was as follows: General-\$124,385.70; Holding Tank - \$632.40; a motion was made by John Benish to accept the Treasurer's Report, 2nd by Fred Thistle - motion carried.

There will be hearing at the Lodi High School for putting a bridge across the Wisconsin river to Merrimac at 10:00 a.m. on Tuesday - August 8, 1989.

The Wisconsin Towns Association will hold meeting later this fall on how to conduct the 1990 census for the towns.

The bills were presented and a motion was made by Fred Thistle to pay the bills presented, 2nd by John Benish - motion carried.

There will be a meeting at the Lodi Administration Building on August 8, 1989 at 7:30 p.m. will all the town boards in the Lodi School District to meet with the new Administrator to discuss school problems and tax money were it is being spent.

The town board would like to hear from the citizens committee on the sanitary landfill closing at the September meeting.

The town board tabled the rezoning of Agricultural land to the September meeting. Before the land can be rezoned the board would like a study of the type of land, run off problems, and have roads put it.

A motion was made by Fred Thistle to have a public hearing on the abandoning of Bachelor Lane in Pleasant View Park as a public access on Tuesday, August 15, 1989 at 8:00 p.m. at the town hall, 2nd by Dave Cole - motion carried.

A motion was made by Fred Thistle to stay with the Laub Group Insurance for the up coming year, 2nd by John Benish - motion carried.

The town board was in favor of Mr. Thompson Board of Adjustments meeting to be held in September for putting up a garage.
