

TOWN OF WEST POINT

The town board of the Town of West Point held the regular monthly meeting on Tuesday - October 3, 1989 at 8:00 p.m. at the Town Hall. The members present were: John Benish-Chairman, Fred Thistle-1st Supervisor, Dave Cole-2nd Supervisor, Edith Eberle-Clerk, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in four places.

Chairman John Benish stated that the DNR agreement for a Pier on East Harmon Road Access and the DNR placement of Waterway Markers will be tabled until a later meeting as the DNR representative did not return his telephone call.

The minutes from the September 7th meeting were read, a motion was made by Fred Thistle to approve the minutes as read, 2nd by Dave Cole - motion carried.

The Treasurers Report was as follows: General - \$16,080.52, Holding Tank - \$632.40; a motion was made by Dave Cole to accept the treasurer's report, 2nd by Fred Thistle - motion carried.

The moratorium of Farm Lands was discussed - Fred Thistle gave his views on the moratorium, there was also 3 people present from the Town of Dekorra who explained how their town was handling there rezoning of farm lands. They have a planning and zoning committee, and an Impact committee within the Town of Dekorra. They will send us copies of their by-laws and other information to help our board to have some guidelines. Therefore the moratorium of farm lands and the environmental sub committee will be tabled until the November meeting.

A motion was made to accept the Assessor Plat by Fred Thistle, 2nd by John Benish - motion carried.

The sanitary landfill will be discussed at the November meeting after the meeting with the citizens committee, Batz Sanitary and Mr. Casey.

A motion was made by Fred Thistle to pay the commercial package policy, 2nd by John Benish - motion carried.

Chairman John Benish will go and talk to the Fire Department about the fire call billing.

Karen Hamilton from Smith Park Road would like to abandon the waterway - it was decided that the town board to go individually and look at the culvert and property and come to the November meeting with their suggestions on the waterway.

A motion was made by John Benish not to approve the additional driveway on Hillcrest Drive for Mr. Tom Eriksen, 2nd Fred Thistle - motion carried.

The town budget meeting will be on October 19, 1989 at the Clerk's home at 7:00 p.m.

A motion was made by John Benish to adjourn the meeting, 2nd by Fred Thistle - motion carried.
