A Cigarette License was presented for Darrell Klingmeyer, a motion was made by Fred Thistle to grant the license, 2nd by ~~Fred Thistle~~ <sup>Dave Cole</sup> - motion carried.

There were two proposals for Auditing the Town of West Point Books for 1990 one from Campbell, and the other one from Virchow & Krause. After discussion a motion was made by Dave Cole to have Virchow & Krause do the audit for \$1,800.00 to \$2,200.00, 2nd by John Benish - yes - 2 no - 1 the motion carried.
