

TOWN OF WEST POINT

The town board of the Town of West Point held there regular monthly meeting on August 8, 1991 at 8:00 p.m. Members present were John Benish-Chairman, Fred Thistle-1st Supervisor, A. Dave Cole-2nd Supervisor, Edith Eberle-Clerk, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in four places.

The minutes were read from the July 2, 1991 meeting. A motion was made by Fred Thistle to approve the minutes, 2nd by Dave Cole-motion carried.

The minutes were read from the July 7, 1991^{special} meeting. A motion was made by Fred Thistle to approve the minutes, 2nd by John Benish-motion carried.

The minutes were read from the July 31, 1991^{special} meeting. A motion was made by Fred Thistle to approve the minutes, 2nd by Dave Cole-motion carried.

The Treasurers report was \$36,185.00. A motion was made by Dave Cole to approve the treasurers report, 2nd by Fred Thistle-motion carried.

A motion was made by Dave Cole to have a Dead End Road Sign put up on Pustaver Road, 2nd by Fred Thistle- motion carried.

The bills were presented. A motion was made by Dave Cole to pay the bills presented, 2nd by Fred Thistle - motion carried

Mr. DeLorman Enge explained the group gathering that will be held on August 16 - 18, 1991. John Benish-Chairman had checked this out with Columbia County Sheriff and had a favorable report. Columbia County Sheriff department will be on call if needed. Columbia County does not have an ordinance for under 5,000 people.

After discussion over the bed and breakfast ordinance for Columbia County - a motion was made by Dave Cole to approve the Bed and Breakfast Ordinance with a variance, 2nd by Fred Thistle - motion carried.

Chairman John Benish received a petition with 45 names on it asking to have a street light put in on Hwy. 60 and Golf Road. A motion was made by Dave Cole to table the street light until September 5, 1991 to hold a public hearing at 7:30 p.m., 2nd by Fred Thistle - motion carried.

The final tally on the questionnaire on Land Use is done and Fred Thistle read the report to the people present and a copy of the report is posted on the bulletin board.

After a lot of discussion a motion was made by Dave Cole to have the town's attorney - Jeff Clark draw up a Resolution for a seven person planning commission for our September 5, 1991 meeting, 2nd by John Benish - motion carried.

A motion was made by Dave Cole to table the Sub Division Ordinance to have more time to review it, 2nd by Fred Thistle - motion carried.

The town board and people that were present went over the recommendations that our town attorney had made on the Hermes and Walter Preliminary Plat. A motion was made by John Benish to table the recommendations until the town board could walk the property with the Columbia County Zoning Administrator, 2nd by Fred Thistle - motion carried.

A motion was made by Dave Cole to adjourn the meeting, 2nd by Fred Thistle - motion carried.
