

TOWN OF WEST POINT

The town board of the Town of West Point held the regular monthly meeting on Thursday, April 9, 1992 at 7:30 p.m. at the Town Hall. The town board members present were: John Benish-Chairman, Fred Thistle-1st Supervisor, and Edith Eberle-Clerk. Absent were Dave Cole-2nd Supervisor, Joan Bader-Treasurer, and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and posted in three places.

The minutes were read from the March 5, 1992 meeting, a motion was made by Fred Thistle to approve the minutes as read, 2nd by John Benish - motion carried.

There was no treasurer report, as Joan Bader was in a car accident.

Dave Cole-2nd Supervisor came at 7:40 p.m.

Mr. Richard Landgraf presented two different copies of WI. Statutes Chapter's 784 and 17 - stating the he felt that the town chairman - John Benish was in violation of these chapter's as he is not living within the Town of West Point. After some discussion - Chairman John Benish handed the gravel over to Fred Thistle to continue the meeting and he left.

A motion was made by Dave Cole to continue the meeting and to hold a special meeting on Tuesday, April 21st, 1992 at 8:00 p.m. to bring the question of the Town Chairman's residency - so the town board could investigate the matter, 2nd by Fred Thistle - motion carried.

A motion was made by Dave Cole to table the bills until Tuesday, April 14, 1992 at 7:30 p.m. - as to find out who is to sign the bills, 2nd by Fred Thistle - motion carried.

It was announced that the weight limits are now off the Town Roads - as of Monday, April 6, 1992.

A motion was made by Dave Cole to have Shawn and Nicholas Eberle mow the town hall lawn, 2nd by Fred Thistle - motion carried.

Roads were discussed that needed brushing, the roads were: Pulvermacher Road, Lovering Road, Ferry View Circle, East Harmon Road, Gastrow Road, Van Ness Road, and Chrisler Road.

Fred Thistle stated he was still getting complaints on Larry Wilkerson's dogs as they are not under control. Fred Thistle asked the town clerk to sent Mr. Wilkerson a letter asking him why his dogs are not under control and to please come to the May 7, 1992 meeting for a explanation.
