

TOWN OF WEST POINT

The town board of the Town of West Point held the regular monthly meeting on Thursday, March 4, 1993 at the Town Hall at 7:30 p.m.. The town board members present were: Fred Thistle-Chairman, Alan Treinen-1st Supervisor, and A. Dave Cole-2nd Supervisor; also present were: Edith Eberle-Clerk, Joan Bader-Treasurer and Harry Sawyer-Assessor.

The meeting was published in the Lodi Enterprise and the Sauk Prairie Star and Posted in four places.

The minutes were read from the February 4, 1993 meeting. A motion was made by Alan Treinen to approve the minutes as read, 2nd by Dave Cole - motion carried.

The minutes were read from the January 28, 1993 meeting. A motion was made by Alan Treinen to approve the minutes as read, 2nd by Fred Thistle - motion carried.

Fred Thistle - town chairman stated that he had met with the town attorney on Mr. Zeman letter and we have heard nothing back as of now.

Fred Thistle - town chairman stated that he had received a letter for the town attorney which states that the town doesn't have to get a bid for a town audit if it is under \$5,000.00. It was also stated that the bid's the town clerk had got to do an audit was between \$2,000.00 and \$2,500.00. The town has only budgeted a \$1,000.00. It was stated that as long as the town has a separate treasurer and clerk we do not need an audit. So the town clerk and the town treasurer are to get to gather and have there books balance.

The Treasurers report was \$87,553.13 in the general account. A motion was made by Dave Cole to accept the Treasurers Report, 2nd by Alan Treinen - motion carried.

The bills were presented, a motion was made by Dave Cole to pay the bills presented, 2nd by Alan Treinen - motion carried.

There was no Planning Commission Report.

A motion was made by Dave Cole to have a Dead End Sign put up at the bottom of the hill on Slack Road, 2nd by Alan Treinen, motion carried.

A motion was made by Dave Cole to approve the Speed Limit Ordinance for Lake Drive and Klamer Road, 2nd by Alan Treinen - motion carried. It was also decided to look at all subdivision in the Town of West Point and a report will be made at the April meeting.

The town board is going to bid out the mowing at the recycling center.

The town of West Point will have street signs put up in Woodland Hills and the Town will bill the developer.

The Erosion Control Ordinance is tabled.

The Town Chairman and the Town Clerk will fill out the form for the American Disabilities Act.

The variance for Mr. William Penn is tabled.

A motion was made by Dave Cole to allow MCI to put a cable under McCubbins Land and Old Sauk Road, 2nd by Alan Treinen - motion carried.

A motion was made by Dave Cole to have weights limits posted on all town roads, 2nd by Alan Treinen - motion carried.

A motion was made by Alan Treinen to change our meeting to the first Thursday of every month - beginning in May of 1993 at 7:30 p.m., 2nd by Dave Cole - motion carried.

A motion was made by Dave Cole to have the Planning Commission meeting on the second and fourth Thursday of every month at 8:00 p.m., 2nd by Alan Treinen - motion carried.

A motion was made by Dave Cole to adjourn the meeting at 9:05 p.m., 2nd by Alan Treinen - motion carried.
