### 2018 Real Estate Taxes

1<sup>st</sup> installment tax payments need to be postmarked by January 31, 2019 to be considered timely.

Tax payments can be made in person at the Town Hall, by mail or online.

When searching for your property tax record(s) in the Columbia County Land Record Suite, select 11040 – Town of West Point.

You can search by parcel number, last name, street name, etc. “Less is more” when it comes to searching. For instance, search for just your last name OR your street name, but NOT both.

On the next screen, select the Taxes option in the Select Detail dropdown to view property tax information.

**Transfer Site/Recycling Center**

Beginning in 2019, all West Point residents and property owners utilizing the West Point Transfer Site will be required to have a Transfer Site Permit. The permit must be placed on the driver side dash and visible for inspection by Transfer Site employees. Permits can be picked up in December and January at the Town Hall during normal business hours or any Saturday from 9am–4pm at the Transfer Site.

Construction dumpsters are available during the months of May and September only. Dumpster use is on a first come first serve basis. The Ag & Silage Plastic dumpster is available at the Transfer Site year round. **2019 Dog Licenses**

Wisconsin State Statues 174.05 and 174.07(1)(b) requires ALL DOGS over the age of 5 months to be licensed **annually** by the Municipal Treasurer. Licensing your dog requires proof of rabies.

**Licensing fees:**

- \$5 for spayed or neutered dogs
- \$10 for unspayed or unneutered dogs.

Please include a self addressed stamped envelope along with your payment when purchasing via mail. *Note: extra postage is required when licensing multiple dogs.*

**Rent the Town Hall for your family gatherings and functions**

- Hall - \$150 | Park Shelter - \$75
- Hall & Park Shelter - \$200
- Damage deposit - \$250 (refundable)
