## Fireworks Permit Application

Wisconsin statute 167.10 prohibits the use or possession of fireworks, as defined under 167.10 (1), without a user's permit issued from the mayor of the city, president of the village or chairperson of the town in which the possession or use is to occur. Permits can only be issued to one of the following; 1) A public authority; 2) A fair association; 3) An amusement park; 4) A park board; 5) A civic organization; 6) Any individual or group of individuals; 7) An agricultural producer for the protection of crops from predatory birds or animals. NOTE: Permits cannot be issued to a minor; they must be 18 years of age, under 167.10 (3) (h). A copy of this permit shall be on file with the clerk of the city, village or town.

(Fireworks cannot be purchased or used prior to the issuing of the permit. Fireworks can be purchased anywhere in this state and the possession of the fireworks is allowed under this permit while the permit holder is transporting the permitted fireworks to the city, town, or village where the possession and use is authorized by this permit. However, the permit holder must take the most reasonable direct route between the location of purchase and the location of the permitted use of fireworks indicated on this permit. Remaining in a non-permitted city, village or town for more than 12 hours means you are no longer "transporting" the permitted fireworks)
